It is further argued that co-accused has already been granted bail by the order of Sh. Deepak Dabas, Ld. ASJ vide order dated 29.05.2020. It is further stated that in view of current situation of pandemic, accused be granted interim bail.

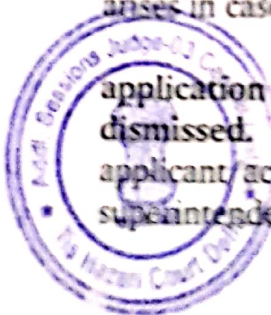
On the other hand, Ld. APP for the State has vehemently opposed the interim bail application of applicant/accused Nitin Tokas submitting that presence of accused at the spot has been verified from the CCTV Footage near the place of occurrence.

Heard. Considered.

The offence involved inter alia is under section 395 IPC which has not been covered under the guidelines laid down by High Powered Committee vide minutes dated 18.05.2020 for grant of interim bail. Further vide minutes dated 20.06.2020 of High Powered Committee, it has been clarified that the offences under section 395 IPC and 364A IPC were deliberately omitted while devising the criteria of bail.

Considering the facts and circumstances of the case and in view of the gravity of the offence, I am not inclined to grant interim bail to the accused. Needless to say no question of parity arises in case of interim bail.

With these observations, the interim bail application of applicant/accused Nitin Tokas is hereby dismissed. Copy of the order be sent to Ld. Counsel for applicant/accused and another copy of order be sent to jail superintendent for information.

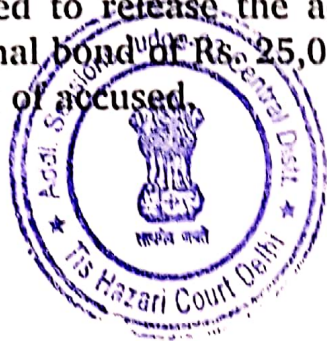

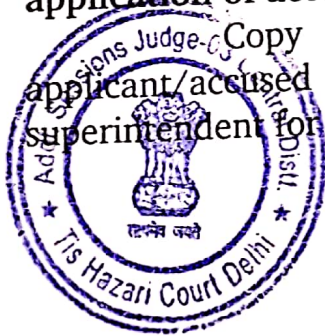


