Ld. Counsel for the applicant has submitted that the applicant is in custody in this case since 28.08.2016 and due to spread of COVID-19 Pandemic the applicant may be admitted to bail and any condition may be imposed. It is further submitted by Ld. Counsel for the applicant that applicant is ready to furnish the local surety and three prosecution witnesses have already been examined and it will take time to resume the normal physical proceedings in the court as presently the virtual hearing are being conducted.

Ld. Addl. P.P. for the State has opposed the bail application and submitted that the offence involved is serious in nature and the deadly weapons were also recovered in the present case. It is further submitted by Ld. Addl. P.P. for the State that material witnesses are yet to be examined and the applicant is not having permanent address of Delhi and in case the applicant is admitted to bail then he may influence or threaten the prosecution witnesses.

I have considered the rival submissions of both the sides and perused the material on record.

Report of SI Satyavir Singh dated 08.07.2020 reflects that country made pistol was also used in the commission of offence in question. Weapons of offence were recovered in this case and

applicant/accused Shahid was also overpowered with country made pistol.

In view of above facts and circumstances and considering the nature and seriousness of the offence in question and also the fact that remaining prosecution witnesses are yet to be examined, I see no merits in the bail application under consideration. Hence, the same is hereby dismissed. However, any expression of opinion made herein shall not tantamount to any expression of opinion made on the merits of the case. Ordered accordingly.



this is an application for interim bail/regular bail. It is submitted that application has been filed in view of the recommendations of the Hon'ble High Powered Committee of the Hon'ble High Court of Delhi and also on the ground of illness of 'Bhanji' of the applicant.

Ld. Addl. P.P. for the State has strongly opposed the application under consideration and submitted that as per report of concerned Jail Superintendent, Central Jail No. 1, Tihar, New Delhi dated 09.07.2020, the applicant/accused Sonu is involved in other cases also bearing FIR No. 896/11-101/2012, PS Jarif Nagar, u/s 304/394/34 IPC and FIR No. 102/2012, PS Jarif Nagar, u/s Nil. Ld. Addl. P.P. for the State has submitted that since the applicant is previously involved in other criminal cases, therefore, the matter is not covered under the recommendations of Hon'ble High Powered Committee.

Ld. Counsel for the applicant has submitted that 'Bhanji' of the applicant is ill, therefore, applicant may be admitted to interim bail.

Ld. Addl. P.P. for the State has highlighted the order dated 29.06.2020 passed in this case and submitted that earlier the applicant had sought interim bail on the ground of illness of his father and said application was dismissed on 29.06.2020 and said order reflects that

Ld. Counsel for the applicant admitted that ground of illness of the father of the applicant was not mentioned in the earlier application for interim bail.

On query put to the Ld. Counsel for the applicant it has been disclosed that parents of 'Bhanji' of the applicant i.e. sister and brother-in-law of the applicant are residing with said 'Bhanji'. In these circumstances it is clear that the parents of the said ill child are there to lookafter her.

Ld. Counsel for the applicant has further submitted that the applicant is not named in FIR and the recovery is doubtful and the allegations are baseless.

Ld. Addl. P.P. for the State has submitted that the offence is serious in nature and no ground is made out to admit the applicant on bail.

I have considered the rival submissions of both the sides and perused the material on record.

In view of overall facts and circumstances and material on record and considering the nature and seriousness of the offence in question, I see no merits in the bail application under consideration. Hence, the applicant/accused cannot be admitted to either regular bail
