It is stated that investigation revealed that the said murder had been committed by the applicant Salman alongwith other accomplices. It is also stated that the tiffinbox and watch of the deceased were recovered from applicant Mohd. Salman.

On the other hand, Ld. Addl. PP for State contends that applicant has been held to be adult for the purposes of trial and has been charged with heinous offences including offence under section 302 IPC. It is accordingly

prayed that the bail application of the applicant ought to be dismissed.

I have heard the arguments and perused the record as well. The applicant Salman is treated as an adult for the purposes of trial. Perusal of the record reflects that FIR has been lodged under section 302/201/397/412/34/356/379/411 IPC. Section 302 IPC is punishable with imprisonment of life and hence, the same does not fall in the Covid criteria for grant of interim bail to the accused persons as laid down by the Hon'ble Delhi High Court. In these circumstances, the bail application of the applicant Salman is declined.






