
1. No case is made out for interference in the impugned order dated 01.07.2020, passed by Ld. MM, directing registration of FIR u/s 156 (3) Cr.PC against the revisionist in respect of cognizable offence reported by the complainant/respondent no. 2 to the police on 18.06.2020.
2. Ld. Trial Court while relying upon the judgment of "**Lalita Kumari Vs. State of U.P. W.P (Cri.) No. 68/2008, dated 12.11.2013**", passed by the Hon'ble Apex Court has observed in the impugned order that there is no provision for preliminary inquiry for registration of FIR where cognizable offence is reported by the aggrieved person against the accused to the police.
3. Ld. Counsel for the revisionist has argued that the above referred judgment of the Hon'ble Apex Court would not apply to the cases where the preliminary inquiry had already been conducted by the police disclosing no offence. Ld. Counsel has further argued that the FIR against the revisionist even otherwise would not have been ordered without obtaining sanction for prosecution u/s 197 Cr.PC, for the revisionist being a public servant.
4. This court has considered the submissions made by Ld. Counsel for the revisionist but could not persuaded itself to agree with him. This court is in complete agreement with the reasoning given by the court below in the



impugned order while directing registration of FIR.

5. In view of foregoing reasons, this revision has no merit and is hereby dismissed.
