As per the reply of the IO, the allegations against the applicant/accused Asha and the co accused are that they have given beating to the complainant and his wife and have taken away Rs.25,000/- from them. It is argued by Ld.Counsel for complainant as well as by Ld. APP for the State that the allegations disclose the offence of robbery which has not been added in the FIR. It is further stated by the IO that the result of medical examination of wife of complainant is awaited; that the custodial interrogation of the applicant and co accused has to be done regarding the money which was stolen from the complainant. However, IO has not clarified in the report as to what investigation has been carried out till date; whether the applicant was called upon to join the investigation or not and whether applicant is cooperating with the investigation or not. 



mentioned. He has further clarified that PC remand of present accused has already been taken and all the interrogation has been done from the accused. IO has also admitted which is also mentioned in the present application that the present applicant has already furnished the particulars of the co accused.
