This is an application for grant of bail to accused on the ground that accused has no previous criminal antecedents and he has been falsely implicated in the present case without any cogent evidence. Further, accused is of young age and having deep roots in the society. It is also stated that present FIR has been registered against the accused maliciously and mischievously with an ulterior motive to harass accused/applicant. Therefore, it is prayed that accused may be released on bail.

Reply to the bail application has been filed.

Ld. Additional Public Prosecutor has opposed the bail application stating that the allegations against the accused/applicant are very serious.

Perusal of record shows that earlier bail application of accused was dismissed on 15.07.2020 and since then no new ground has come on record except the fact that co-accused have been granted bail by the Duty Magistrate.

It is worthwhile to note that co-accused were granted bail on the basis of affidavit filed by the complainant stating that main accused Nahid Hussain is his close friend and he was not involved in this case whereas investigation done so far clearly reflects the role of accused Nahid Hussain. Accused Nahid Hussain was

granted bail on 30.06.2020 whereas the bail application of accused/applicant was dismissed on 15.07.2020 i.e. after the bail was granted to accused Nahid Hussain.

The allegations are serious and after dismissal of the bail application on 15.07.2020, no new ground has been put forward to consider this bail application favourably. The offences are non-compoundable, hence, I do not deem it fit to admit accused on bail. Hence, the bail application of accused/applicant Pintu Kumar stands dismissed.





This is an application for grant of anticipatory bail to accused/applicant namely Raju stating *inter alia*, that accused is innocent and has been falsely implicated in the present case. It is stated that accused not involved in any other criminal case. It is prayed that since there is apprehension of arrest, accused/applicant may be granted anticipatory bail.

Reply to the bail application has been filed.

Ld. Additional Public Prosecutor has opposed the bail application stating that custodial interrogation of accused is required in the present case.

As per Investigating Officer, accused/applicant has not cooperated or joined the investigation. As per prosecution, co-accused was the bonafide purchaser of stolen mobile phone that is why he was granted bail, but the applicant is main accused suspected of theft in the present case.



Considering the entire facts of the case, as there are specific and serious allegations against the accused/applicant, the fact that he is not joining the investigation and his custodial interrogation will be required to recover the stolen articles, I do not deem it fit to grant anticipatory bail to him. Hence, the anticipatory bail application of accused / applicant Raju stands dismissed.

This is an application for grant of bail moved on behalf of accused Sunil @ Jhalku on the ground that he is in judicial custody since 17.02.2020. Further, chargesheet has been filed in the case and custodial interrogation of accused/applicant is not required. It is also stated that accused is the sole bread earner of his family consisting of his parents, wife and three children. Father of accused is suffering from TB and his wife is a patient of depression. Further, due to current situation of Covid-19, it has become very difficult for family of accused to survive, hence it is prayed that accused may be released on bail.

Reply to the bail application has been filed.

In support of his arguments, Ld. Counsel for accused/applicant has relied on judgments of the Hon'ble Supreme Court passed in *Criminal Appeal no. 13/1968 titled as Jani Gulab Shaikh Vs State of Maharashtra* and by Hon'ble High Court passed in *Criminal Appeal no. 385/1998 titled as Satpal Vs State*.

Ld. Additional Public Prosecutor has opposed the bail application stating that there are specific allegations against the accused, which are quite serious. Dismissal of bail application is prayed for. It is further submitted that the applicant

has moved a bail application earlier also, which was dismissed on 10.06.2020 and thereafter there is no change in circumstances.

As per reply of Investigating Officer, accused/applicant is the main accused in the present case as he has beaten the deceased and dragged him on road, again beat him and thereafter left the spot alongwith co-accused. As per post-mortem report, the injuries caused to the deceased were sufficient to cause death. Further, the entire incident of beating the deceased has been captured in local CCTV footage. There is apprehension that if accused is released on bail, he may threaten the family of deceased and may win over the witnesses as deceased was the distant relative of accused /applicant. It is also stated that accused/applicant is the resident of Nepal and there is possibility that if he is released on bail, he may abscond or flee from justice.

Perusal of record shows that earlier bail application of accused/applicant was dismissed on 10.06.2020 and since then no new ground has emerged on record which entitles the accused/applicant to bail. It is submitted by Ld. Counsel for accused / applicant that chargesheet has been filed, which is not a sufficient ground to grant bail to accused.

Keeping in view the afore-discussed facts and circumstances and considering the gravity of offence that the applicant has caused the death of a person in the present case, I do not deem it fit to admit accused on bail. Hence, the bail application of accused/applicant Sunil @ Jalku stands dismissed.





As per reply, accused/applicant is BC of area and involved in number of criminal cases.


