
This matter is listed today for arguments.

Ld. Counsel for the applicant/accused submits that in this case, the applicant/accused is in custody since 16.08.2017. He further submits that the applicant/accused is first time offender as no other case except the present case is registered against him till date. Ld. Counsel for the applicant/accused further submits that only two witnesses are yet to be examined in this case and due to present pandemic situation, the trial may take long time.

Ld. Addl. P.P. for the State submits that there is no change of circumstance in this case and moreover, the Hon'ble High Court of Delhi has already rejected the regular bail application of the applicant/accused twice. He further submits that some witnesses are yet to be examined. Ld. Addl. P.P. for the State has opposed the regular bail application.



I have considered the above submission and perused the file.

Perusal of the file shows that vide order dt. 19.09.2018 in BAIL APPLN. 2197/2018 titled as Uma Shankar Tiwari Vs. State, the Hon'ble High Court of Delhi has dismissed the bail application of the applicant/accused. Further, vide order dt. 28.03.2019 in BAIL APPLN. 2882/2018, titled as Uma Shankar Tiwari Vs. State, the Hon'ble High Court of Delhi, again dismissed the bail application of the applicant/accused.

Perusal of the file shows that after 28.03.2019, four witnesses were examined and two witnesses were partly examined. Some other witnesses are yet to be examined.

In the instant case, the allegation against the applicant/accused are that on 04.08.2017, at about 04:00 PM, the applicant/accused, who earlier used to work as Sewadar in Sanatan Dharam Mandir, came to the house of the victim. Victim and the applicant/accused were also used to be known to each other as on earlier occasions, considering the poor background of the applicant/accused, victim used to give him clothes etc. Thereafter, applicant/accused left the services of said Mandir and had gone to his village in U.P. After that, on 04.08.2017, as the applicant/accused met her (victim) after long time and hence, she allowed him to enter her house and he asked one glass of water from her. The victim went

inside her house and gave the water to the applicant/accused and after drinking water, the applicant/accused again asked one more glass of water and then she again went inside to bring the water and after drinking water, applicant/accused asked for handkerchief. Thereafter, the victim again went inside to bring the handkerchief and in the meanwhile, the applicant/accused put his hand on her mouth and also put knife on her neck and demanded money from her and when she refused to give money, he inflicted injuries on her neck and thereafter, she fell on the bed. The applicant/accused also assaulted her (victim) on her abdomen and she also shouted loudly and in the meanwhile, the applicant/accused took the money from her purse which was lying on the table and ran away from there.

During the course of investigation, the weapon of offence i.e. knife was recovered from the applicant/accused and same was sent to the FSL and further, the blood of injured and blood on clothes of injured and blood from bed sheet were matched with blood found on knife, as recovered from the applicant/accused.

Moreover, apart from the bail applications of the applicant/accused as dismissed by the Hon'ble High Court of Delhi twice, the trial Court/Ld. Predecessor of this Court has also dismissed the bail applications of the applicant/accused i.e. on 13.08.2018 and 20.11.2018 also.


Thus, keeping in view all the above facts and

circumstances and also considering the gravity of offence, this Court does not inclined to grant regular bail to the applicant/accused as no ground of bail is made out at this stage.

Accordingly, the bail application is dismissed
