In the event of apprehension/arrest, applicant be released on bail on furnishing a bail bond in the sum of Rs. 25,000/- with one surety in the like amount to the satisfaction of the Ld. Duty MM / Ld. MM concerned. However, he shall not leave the country without taking permission of the Ld. MM/ trial Court and shall present himself before the IO/SHO/MM/Trial Court if so required in writing by either of them.

At this stage, Ld. Counsel for applicant submits that the applicant is not available in Delhi as he went to his home State Gujarat. He prays that the applicant be granted one week’s time to return to Delhi to furnish Bail Bonds. The prayer made so is granted.

Applicant may furnish Bail Bonds within one week from today in terms of above directions. Till then no coercive action be taken against applicant in this FIR.

This Court has considered the rival submissions of the parties. Admittedly, the applicant/accused is facing allegations punishable u/s 363/363A/368/370/120B/34 IPC, which are very

**ORDER ON BAIL APPLICATION**

Present : Sh. Manoj Garg, Ld. APP for the State.

None for the applicant/ accused.

Matter is fixed for orders today.

Briefly stated, the present FIR came to be registered on the basis of a complaint filed by one Sh. Jugal Kishore, who allegedly received calls for extorting money on his mobile phone from different mobile numbers (as mentioned in the FIR). The complainant refused to pay the extortion money. Subsequently, on 28/11/2019, at around 1:25 AM (mid night), three rounds were fired on the house of the complainant. Two rounds struck on the door of the complainant's house and one of the rounds struck on the wall of the complainant's house. The complainant categorically alleges that the extortion calls were made by one Sh. Mahesh @ Mannu, who is stated to be detained in jail currently. The complainant further alleges that the firing incident is a consequence of his refusal to pay the extortion money, as demanded by the said Sh. Mahesh @ Mannu.

It was submitted by the Ld. Counsel for the applicant/ accused that the name of the present applicant Ashok Kumar @ Bichwa is not available in the FIR. It was further submitted that the present applicant joined the proceedings as and when he was called by the police. It was further submitted that the present applicant Ashok Kumar @ Bichwa is in judicial custody since 18/06/2020. It was further submitted that the CDRs of mobile phones do not reflect anything adverse against the present applicant Ashok Kumar @ Bichwa. It was further submitted that no recovery is to be effected from the present applicant. Lastly, it was submitted that the present applicant Ashok Kumar @ Bichwa shall join the investigation/ proceedings as and when called by the police Authorities.

Reply filed by the IO reveals that the present applicant namely Ashok @ Bichwa was arrested in the present FIR on the basis of a secret information. The police claims that the present applicant was a party to the conspiracy allegedly hatched by said Sh. Mahesh @ Mannu to extort money from the complainant Sh. Jugal Kishore.

IO further submitted, during the course of arguments, that the present applicant Ashok Kumar @ Bichwa is residing in the same locality/ area, where the residence of the complainant is situated. It was further submitted that the present applicant was instrumental in pointing out the residence of the complainant to accused persons who opened fire on the date of occurrence. It was further submitted that during investigation, a newspaper cutting bearing the mobile numbers of said Sh. Mahesh @ Mannu and the shooter Sh. Bhanu Pratap was also recovered from the possession of the present applicant Ashok Kumar @ Bichwa. It was further

submitted that the weapon of offence is yet to be recovered and absconding accused persons are yet to be arrested. It was further submitted that without the inputs of the present applicant, the shooters engaged by the said Sh. Mahesh @ Mannu, could not have fired shots at the residence of complainant on the date of incident. Accordingly, the police opposes the grant of bail to the applicant/ accused Ashok Kumar @ Bichwa.

This Court has considered the facts and circumstances of the present matter. No doubt, the present applicant Ashok Kumar @ Bichwa is languishing in custody since 18/06/2020 and till date, the only material collected against the present applicant Ashok Kumar @ Bichwa is the newspaper cutting which allegedly bears the mobile numbers of the main conspirator namely Sh. Mahesh @ Mannu and one of the shooters namely Sh. Bhanu Pratap. However, IO submits that all the persons involved in the present conspiracy were in contact with each other by means of whatsapp calls and he has already taken steps to seek details of the calls between the accused persons. IO submits that the whatsapp Authorities are yet to supply him the entire records, which would clearly establish the existence of a conspiracy, of which the present applicant was an active member. The investigation is still at a preliminary stage. It would not be appropriate to enlarge the present applicant on bail, keeping in view the seriousness of the allegations levelled against him. Accordingly, the present bail application stands dismissed. A copy of this order be given dasti to the Ld. Counsel for the applicant/ accused, as requested.
