

Ld. Counsel for the applicant/accused Sanjay Mohindroo has moved an application for extension of permission to travel abroad for six months.

I have heard Ld. Counsel for the parties.

Ld. Counsel for applicant/accused no. 2. Sanjay Mohindroo submits that accused no. 2 had gone to Oman on an assignment and is presently stuck up there due to worldwide Covid-19 pandemic and is unable to return to India as no flights to or from Oman are permitted. Ld. Counsel for



accused further submits that it is not clear as to when Government of India would permit overseas flights to operate in India.


Ld. Counsel for the accused submits that the applicant undertakes to return to India and physically appear before the Court. It is submitted that vide order dated 29.06.2020, accused was granted three months permission to stay abroad. Ld. Counsel for accused submits that the applicant/accused may be permitted to stay at Oman and other countries and places as per permission granted vide order dated 20.12.2019 for further six months.

Ld. Counsel for applicant/accused no. 2 submits that applicant has roots in the society and is permanent resident of India and his family is residing in India. Ld. Counsel for applicant/accused no. 2 submitted that accused does not dispute his identity nor shall delay the trial due to his absence. It is also submitted that there is no likelihood of accused fleeing from justice or interrupt legal proceedings.

Reply is not filed by CBI, however Ld counsel for CBI objected to the submissions made by Ld. Counsel for accused Sanjay Mohindroo. Ld. Counsel for the CBI also submitted that if this court extends the permission to the accused to stay abroad, it should be subject to high security.

I have gone through the material on record.

Vide order dated 20.12.2019, applicant/accused no. 2, Sanjay Mohindroo was permitted to travel to Bahrain, Oman Kuwait, Qatar, Saudi Arabia, United Arab Emirates, Turkey Egypt, Ukraine, Myanmar, Thailand, Indonesia, Philippines and Thailand for a period of six months subject to conditions as mentioned in the said order. Accused was further granted



permission to stay abroad for further three months vide order dated 29.06.2020.




The application filed by applicant/accused no 2, Sanjay Mohindroo is disposed of.
