Arguments heard. Reply of the bail application and the verification of death certificate of father of accused filed by the IO SI Rahul perused.


By way of the present application, interim bail for a period of 40 days has been sought on the ground that the father of the applicant/accused expired on 13.06.2020 and the presence of the applicant/accused is required for performing 40th days ceremony of his father. It is submitted by the counsel for the applicant/accused that the accused shall abide by all the terms and conditions impose while granting the interim bail to him. It is prayed that interim bail for a period of 40 days be granted to the applicant/accused so that he can perform the 40th days last rite ceremony of his father.

The bail application is opposed by the Ld. Addl. PP. She submitted that no specific ceremony or 40th days ceremony which is to be performed by the applicant/accused is mentioned in the bail application. She submitted that this application is nothing but an ploy to release the applicant/accused on interim bail from the Jail.

I have heard the submissions of both the sides. The factum of death of the father of the victim has been verified by the IO. The father of the applicant/accused expired on 13.06.2020 and his last rite has already been performed. No specific ritual or 40th days ceremony has been mentioned in the application. The allegations levelled against the applicant/accused are also serious in nature. Keeping in view the overall facts and circumstances of the case, no ground for interim bail is made out. The bail application is accordingly dismissed.
