
This application for extension of interim bail has been filed on behalf of the applicant/accused Prem Singh @ Lal Singh and the same is listed today for consideration.

Perusal of order dt. 03.07.2020 shows that the applicant/accused Prem Singh @ Lal Singh was granted interim bail for a period of 15 days.

going to expire on 21.07.2020.


Vide order dt. 13.07.2020, in W.P.(C) 3037/2020 titled as **Court On Its Own Motion Vs. State &Ors.**, the Hon'ble High Court of Delhi has clarified that the order of extension of bail/interim bail/Parole shall be applicable to all the under-trials/convicts, who are on bail/interim bail or Parole as on date irrespective of the fact that they were released on bail/interim bail or parole before or after 16.03.2020.

Vide above order dt. 13.07.2020, the Hon'ble High Court of Delhi has further extended the implementation of directions contained in order dt. 25.03.2020, 15.05.2020 and 15.06.2020 till 31.08.2020 with the same terms and conditions.

Thus, as such, in view of the above, the interim bail of the applicant/accused already stands extended till 31.08.2020 in terms of above directions of the Hon'ble High Court of Delhi.

Thus, the present application is accordingly disposed of.


This application u/s 439 Cr.P.C. has been filed on behalf of the applicant/accused for grant of interim bail.



As per the verification report of medical documents of father of the applicant/accused, it is reported that father of the applicant/accused was admitted in SMS hospital, Rajgarh Road, Hisar, Haryana on 18.05.2020 and discharged on 21.05.2020 and he was admitted only for three days, which was two months ago.

Ld. Substitute Addl. P.P. for the State has opposed the application of the applicant/accused and submitted that there is no urgency for granting the interim bail to the applicant/accused.


Ld. Counsel for the applicant/accused submits that father of the applicant/accused is still not well due to heart ailment and hence, in this pandemic situation, the applicant/accused may be granted interim bail, so that he may take care of his father.

I have considered the above submission and perused the report.

There is no medical documents of father of the applicant/accused after 21.05.2020. Thus, the ailment of father of the applicant/accused is stated to be two months back and now father of the applicant/accused has already been discharged on 21.05.2020.

Considering the above report, no ground for grant of interim bail is made out. Therefore, the application is dismissed.

Accordingly, the present application of the applicant/accused for grant of interim bail is disposed of.

Today fresh reply/report has been filed by SI Sudhir Rathee.

As per report, in the family of the applicant/accused, there are his father aged 45 years, mother aged 40 years, his wife Deepa aged 22 years, his brothers aged 15 years and 12 years and one sister Bimla aged 18 years.

It is also reported that the father of the applicant/accused used to remain ill and the applicant/accused is the only earning family member in his family. It is also reported that the father of the applicant/accused is depending on agriculture for livelihood.

Ld. counsel for the applicant submits that the applicant/accused is the only earning member in his family and his entire family is depending upon the applicant/accused. He further submits that sister of the applicant/accused is not residing alongwith the family. He further submits that the applicant/accused has no previous involvement except the present case and in these circumstances, he may be granted interim bail.

Ld. Substitute Addl. P.P.for the state has opposed the interim bail application.


I have considered the above submission and reply.

As per reply, in the family of the applicant/accused, there are three adult persons in his family i.e. father of the applicant namely Arjun aged 45 years, mother Kumkum aged about 40 years and wife Deepa aged about 22 years. Moreover, sister of the applicant/accused is 18 years old as per the report. Moreover, as per report, the family of the applicant is dependent upon the agriculture. Further, no specific ailment of father of the applicant/accused has been mentioned in the reply/report. Moreover, in the application, no medical document of father of the applicant/accused has been annexed and in the report filed by SI Sudhir Rathee, there is no mention of any specific ailment of father of the applicant/accused. Further, Id. Counsel for the applicant/accused has also not mentioned any specific ailment from which the father of the applicant/accused is suffering.

Therefore, keeping in view the above facts & circumstances and report of SI Sudhir Rathee, no ground of interim bail is made out.

Accordingly, the application for interim bail of the applicant/accused is dismissed.


