





That the medical condition of the father of the accused is not good and therefore they have decided to solemnized the marriage of sister of accused-applicant. That the marriage of sister of the accused-applicant is fixed for 14.01.2021. That the marriage of the sister of accused-applicant Mehru Nisha is fixed for 14.01.2021: That the applicant/accused is only male person, to manage fund and arrangement for marriage of his sister.


Ld. Addl. PP submits that Ld. Addl.PP submits that as per report accused-applicant does not have any previous involvement except in the present case FIR No. 243/2014 and 245/2017 consolidated for the purposes of trial. That

As per report, the factum of solemnization of marriage of sister of accused-applicant on 14.01.2021 is verified and there is no previous involvement of the accused-applicant besides the present case FIRs which have been consolidated for the purposes of trial. In such totality of the facts and circumstances therefore five days interim bail is granted to the accused-applicant for the purposes of marriage of his sister upon his furnishing personal bond with one local surety in the sum of Rs. 50,000/- each and subject to the condition that he shall mention the mobile phone number to be used by him which number it shall be ensure dis kept on switched on mode with location activated and shared with the IO at all times. He shall not leave the NCR region without prior permission of the IO. He shall surrender on the expiry of the interim bail period.



This is an application for modification of order dated 17.10.2020 on behalf of accused-applicant Javed in case FIR No. 29/2019.

Ld. counsel for the accused-applicant submits that accused-applicant Javed was granted regular bail vide order dated 17.10.2020 subject to his furnishing two sureties, one being local surety. It is submitted that accused-applicant is resident of Hapur and has arranged sureties who are also residents of Hapur, UP and that Hapur does not fall in the territory of NCT, Delhi but would fall in the NCR region and the order dated 17.10.2020 may be modified to the effect that local surety of NCR region may be accepted.

Taking into consideration that the accused-applicant has been granted bail vide order dated 17.10.2020 and has not been able to arrange local surety being resident of NCT, Delhi and sureties that are sought to be furnished are residents of NCR region, order dated 17.10.2020 is modified to the extent that one surety from NCR region is ordered to accepted.



Application stands disposed of accordingly.
