Ld. Counsel for the applicants/accused persons has submitted that accused persons have been falsely implicated in the present case, accused Deepak is aged about 22 years and accused Abhishek Chandra is aged about 25 years, both the accused persons have clean antecedents, accused persons undertake not to impede the trial of the case or tamper with prosecution witnesses, that by invoking Section 511 IPC the punishment for the alleged offence is reduced to 1½ years of imprisonment and therefore, the offence has now become bailable in view of Part-II to first schedule of CrPC and that both the above accused persons be granted bail.

On the other hand, IO HC Baldev Raj in his report, has submitted that both the above accused persons were arrested on the spot who were attempting to snatch away the mobile phone of complainant and objected to release of the accused on the ground that their addresses have not been verified. However, IO has orally submitted that there are no previous criminal involvement of both the above accused persons.

Ld. APP for the State also submits that the accused persons may not be granted bail in view of non-verification of their addresses.

Heard. Perused.

The contention of Ld. Counsel for the accused that by invoking of Section 511 IPC, the offence has become bailable is incorrect in view of this Court. Section 511 IPC only reduces the quantum of punishment but does not change the nature of the offence to bailable. Moreover, Part-II of

first Schedule of CrPC is applicable to “offences against other laws” and not to offences punishable under IPC. However, keeping in view the overall facts & circumstances of the case as well as the age of both the accused persons, the fact that none of the above accused persons have any previous criminal record, both the bail applications of the above two accused are allowed.

Accused Abhishek Chandra is admitted to bail on furnishing personal bond in the sum of Rs.15,000/- with one surety in the like amount subject to the satisfaction of Ld. Duty MM concerned, subject to verification of his address and subject to conditions that :

1. He shall not threaten or influence the complainant/prosecution witnesses.
2. He shall join the investigation as and when he is called upon by the IO.
3. He shall not tamper with evidence.
