4. Ld. Counsel for the applicant conceded that the case of the applicant is not covered under criteria formulated by Hon'ble High Powered Committee *vide* Minutes of Meeting dated 04.05.2021 and 11.05.2021.
5. Ld. Counsel for the applicant submitted that the applicant is in judicial custody since 5 years and he be released on bail on humanitarian ground as he has the responsibility to maintain his wife and minor children.

6. The applicant is accused of committing robbery by using a country made pistol. He was identified in the Test Identification Parade (TIP). This Court does not find any reason to take any humanitarian view, in view of the gravity of the offence, severity of the punishment and manner of the commission of the offence.

7. Accordingly, the application U/s 439 of the Code for interim bail in respect of the applicant, namely, Gurmukh Singh is dismissed.

6. In Minutes of Meeting dated 31.07.2020 at item No. 6 on "*Consideration of the Representations received*" Hon'ble High Powered Committee while dealing with a similar situation pertaining to offence U/s 302/397 IPC observed as under:

*“It is pertinent to mention here that this Committee in its meeting dated 18.05.2020 had recommended release of, “Under trial prisoners (UTPs) facing trial for a case under Section 302 IPC and are in jail for more than two years with no involvement in any other case”, for grant of interim bail for a period of 45 days. It is apparent that that applicant in the present FIR is facing trial for an additional offence U/s 397 IPC besides offence U/s 302 IPC. Members of the Committee while laying down the criteria on 18.05.2020 had intentionally omitted such like offences i.e. dacoity, robbery, kidnapping for ransome etc. The said class/category of cases and sections of IPC, therefore, were not mentioned in the minutes while laying down criteria in meeting dated 18.05.2020.”*

7. The applicant is also involved in 5 criminal cases in which he has been convicted in 2 criminal cases.

8. Accordingly, the application U/s 439 of the Code for interim bail in respect of the applicant, namely, Rakesh @ Sonu @ PK is dismissed.

**ORDER**

1. This is an application U/s 439 of '*The Code of Criminal Procedure, 1973*' (Hereinafter referred to as '*the Code*') seeking interim bail in respect of the accused, namely, Ishtiaq Ali (Hereinafter referred to as '*the applicant*').
2. Reply filed. Copy supplied.
3. Heard.
4. Ld. Counsel for the applicant submitted that the applicant is in judicial custody since 14.02.2019. The applicant is in judicial custody since more than 2 years. He submitted that the case of the applicant is squarely covered under the guidelines laid down by High Powered Committee (HPC) dated 11.05.2021. He submitted that the applicant is not involved in any other criminal case.

5. Ld. Counsel for the complainant submitted that the case of the applicant is not covered under criteria.

6. Besides offence U/s 302 IPC, the applicant is also facing trial for offence U/s 397 IPC.

7. It appears that robbery and dacoity cases are not included in the criteria for grant of bail. Likewise, in minutes of meeting dated 31.07.2020 at item No. 6 on "Consideration of the Representations received" Hon'ble High Powered Committee while dealing with a similar situation pertaining to offence U/s 302/397 IPC observed as under:

*"It is pertinent to mention here that this Committee in its meeting dated 18.05.2020 had recommended release of, "Under trial prisoners (UTPs) facing trial for a case under Section 302 IPC and are in jail for more than two years with no involvement in any other case", for grant of interim bail for a period of 45 days. It is apparent that that applicant in the present FIR is facing trial for an additional offence U/s 397 IPC besides offence U/s 302 IPC. Members of the Committee while laying down the criteria on 18.05.2020 had intentionally omitted such like offences i.e. dacoity, robbery, kidnapping for ransome etc. The said class/category of cases and sections of IPC, therefore, were not mentioned in the minutes while laying down criteria in meeting dated 18.05.2020."*
