along with co-accused persons had robbed the



complainant/victim of a sum of Rs. 50,000/-. Accused/applicant was carrying weapon i.e. pistol at the time of commission of offence and Section 397 IPC is prima facie attracted towards present accused/applicant. Statement of complainant/victim is yet to be recorded in court. Previous bail application filed on behalf of accused/applicant was dismissed vide order dated 02.02.2021. Accused/applicant is a habitual offender and previously also he was involved in 3-4 cases of similar nature.

Keeping in view the totality of facts and circumstances, I find no merits in the application filed by accused/applicant for grant of bail. The same is hereby dismissed and disposed of accordingly.
