
During the course of arguments, it was submitted by Addl. P.P. for the State that the allegations against the accused are serious in nature and he can abscond, if the

interim bail is granted to him and the present interim bail application of the accused be dismissed.


The factum regarding pregnancy and expected date of delivery of wife of the accused is not disputed. Expected date of delivery of wife of the accused is stated to be 31/07/2021. Accused is stated to be not involved in any other case. Considering the facts, circumstances and in view of the submissions made and without going into the merits of the present case, the present interim bail application of the accused Sanjeev is allowed and accused is admitted to **interim bail for the period of fifteen days** on furnishing personal bond and surety bonds in the sum of Rs. 25,000/- each with two sureties each of like amount to the satisfaction of the Court subject to the conditions that:-

- i) *Accused shall not flee from the justice;*
- ii) *Accused shall not tamper with the evidence;*
- iii) *Accused shall not threaten or contact in any manner to the prosecution witnesses;*
- iv) *Accused shall not leave the country without permission of the Court;*
- v) *Accused shall convey any change of address immediately to the IO and the court;*
- vi) *Accused shall also provide his mobile number to the IO;*
- vii) *Accused shall mark his attendance before the concerned IO (and if IO is not available then to concerned SHO) on each and every day through mobile by sharing his location with the SHO/IO;*
- viii) *Accused shall further make a call, preferably by audio plus video mode to concerned IO (and if IO is not available then to concerned SHO) on each and every day between 10:00 AM to 5:00 PM;*
- ix) *Accused shall keep his such mobile number 'Switched On' at all the time;*

- x) Accused shall not indulge in any kind of criminal activities;*
- xi) Accused shall follow Covid-19 protocol/guidelines issued by Central Government/State Government/Competent Authorities;*
- xii) The period of interim bail of 15 days shall commence from the date of release of the accused from Jail;*
- xiii) Accused is directed to furnish personal bond/surety bonds on or before 31/07/2021;*
- xiv) Accused shall not seek further extension of interim bail on any ground;*
- xv) Accused shall surrender before the concerned Jail Superintendent after expiry of interim bail period;*




By way of present order, this Court shall disposed of interim bail application of the accused Shanker Singh.

During the course of arguments, it was submitted by counsel for the accused Shanker Singh that accused has been falsely implicated in the present case. It was further submitted that marriage of daughter of the accused is to be solemnized on 20/07/2021 and presence of accused is required in the marriage of his daughter and interim bail for the period of 30 days be granted to the accused for attending the marriage and other ceremonies of his daughter. It was further submitted that the accused shall be abide by all terms and conditions, if the interim bail is granted to the accused and accused shall surrender after the interim bail period.

During the course of arguments, it was submitted by Addl. P.P. for the State that the allegations against the accused are serious in nature and he can abscond, if the interim bail is granted to him. It was further submitted that accused Shanker Singh is one of the main culprits, who entered into conspiracy to murder Gangesh Jha, Pinki and their associates by hiring sharp shooters and they hired co-accused Ankit and Ashu, who open fired on them and caused death of Gangesh Jha and injuries to Pinki and Deepak. It was further submitted that as informed by counsel for the complainant, the accused persons had threatened complainant/witnesses and complaints in this regard have been filed before the Police. It was further submitted that the present case is at the stage of prosecution evidence and the complainant/public witnesses are yet to be examined and if the accused is released on interim bail, there is possibility that he may influence the witnesses. It was further submitted that accused is habitual offender and he is previously involved in four other criminal cases of different nature and the present interim bail application of the accused be dismissed.

By way of the present interim bail application, the accused Shanker Singh has prayed for interim bail for a period of 30 days for attending the marriage and other ceremonies of his daughter. Marriage of daughter of the accused is stated to be solemnized on 20/07/2021. In the present case, charge for the offences u/s. 302/307/120-B/34 IPC was framed against the accused persons. The present case is at the stage of prosecution evidence and complainant/public witnesses are yet to be examined. The accused was absconding in the present case and process u/s 82 Cr.P.C was issued against him and thereafter, he was arrested and supplementary charge-sheet was filed. The accused is stated to be habitual offender and he is stated to be involved in four other criminal cases of different nature. Keeping in view the facts, circumstances of the case, gravity of offence, nature of serious allegations levelled against the accused and stage of the trial, this court is not inclined to grant the interim bail to the accused Shanker Singh as prayed in the present interim bail application. ***However, accused Shanker Singh is hereby granted custody parole for 20/07/2021 for six hours from 12:00 PM to 6:00 PM only for attending the marriage of his daughter, excluding the traveling time, at the cost to be incurred by the applicant/***


