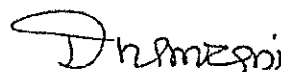

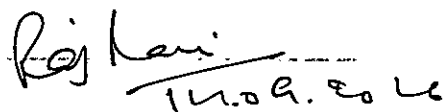

"The Judgment rendered by the District Courts in Civil Petitions and Civil Suits shall have a list of witnesses and exhibits at the end in an annexure.

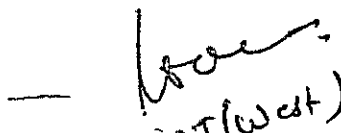
The appendix in Civil matters shall be as per FORM 'A' appended to this Practice Direction.
