NOTIFICATION

It is hereby notified for general information that, pursuant to the Order dated 27.06.2026 passed by the Disciplinary Committee of the **Bar Council of India** in Tr. Case No. 60/2016 and Review Petition No. 03/2026, titled "Mr. Manoj Jain, Spl. Judge (PC Act), CBI, Rouse Avenue Vs. Mr. Harish Chandra Tiwari (Harish Tiwari)", Mr. Harish Chandra Tiwari (Harish Tiwari), Advocate, Enrolment No. D/316/1995, resident of D-28, UGF, Hauz Khas, New Delhi-110016, has been held guilty of professional misconduct and other misconduct. Accordingly, the Disciplinary Committee of the Bar Council of India has ordered that the respondent shall be suspended from practising as an Advocate in or before any Court of Law for a period of five (5) years.

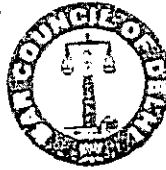
It is further notified that the aforesaid period of suspension shall be reckoned after giving due adjustment for the period of suspension already undergone by the respondent, in terms of the aforesaid Order.

In this regard, it is pertinent to mention here that, pursuant to the Order dated 13.04.2026 passed by the Disciplinary Committee of the Bar Council of India, the Bar Council of Delhi, vide Notification No. **480/GEN/SF/2024** dated **11.09.2024**, had suspended the respondent's licence to practise for a period of five (5) years. The said order was subsequently recalled vide Order dated 17.04.2026. During the intervening period, the respondent had already undergone suspension for a period of one (1) year, seven (07) months and six (06) days. The said period shall be duly adjusted against the five-year period of suspension imposed under the present Order.

In pursuance of the Order dated **27.06.2026** passed by the Disciplinary Committee of the Bar Council of India, the licence to practise of Mr. Harish Chandra Tiwari has been suspended for a period of five (05) years, with effect from **27.06.2026 to 26.06.2031**.

It is, however, clarified that the Respondent had already undergone suspension for a period of one (01) year, seven (07) months and six (06) days, pursuant to the Bar Council of Delhi Notification dated 11.09.2024.

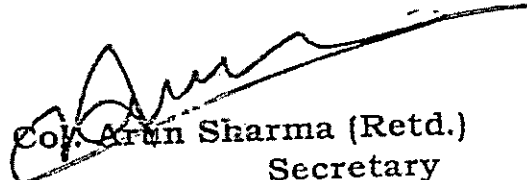

The aforesaid period of suspension shall be duly adjusted against the five year period of suspension imposed under the present Order. Accordingly, after giving due adjustment of the period already undergone, the suspension of the Respondent's licence to practise shall remain operative up to **20.11.2029**.

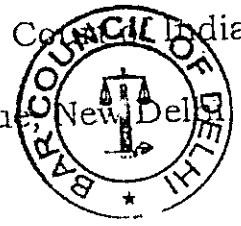
During the period of suspension, the Respondent shall not practise as an Advocate before any Court, Tribunal, Authority or other forum where an Advocate is entitled to practise.

Accordingly, after giving effect to the aforesaid adjustment of the period of suspension already undergone, the licence to practise of **Mr. Harish Chandra Tiwari (Harish Tiwari), Advocate [Enrolment No. D/316/1995]**, shall remain suspended upto **20.11.2029**.
