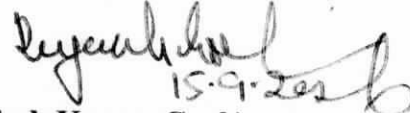

1. The judicial officers shall be under the control of the Principal District & Sessions Judge of the district to which they have been allocated.
2. All Relieving JMFCs/Civil Judges shall perform all judicial work except deciding the cases finally. However, if they are deputed in Evening/Weekend Court or in a Court, where the officer is on long leave, i.e., beyond one month, in such cases, the Relieving JMFC/Civil Judge are empowered to decide the cases finally. All Principal District and Sessions Judges shall keep record of the work done by the Relieving JMFCs/Civil Judges posted in their respective districts and shall forward the same to the High Court on quarterly basis or till they get regular posting, whichever is earlier.
