**ORDER**

As telephonically directed by Ld. Principal District & Sessions Judge-cum-Special Judge, (PC Act) (CBI), RADC, New Delhi, in partial modification of the Duty Judge Roster No. D.R. (SPL. Judges)/RACC/Gaz/2026/21366-21418/C dated 24.08.2026, it is hereby clarified that in the eventuality of any matter pertaining to NIA/UAPA received beyond the regular Court hours, the same shall be put up before the senior most Ld. Special Exclusive Court dealing with NIA/UAPA cases, who may assign the matter to himself/herself or assign the same to any other Special Exclusive Court designated for trying such cases. Such cases pertaining to NIA/UAPA shall not be dealt with by the Ld. CJM or ACJMs or the Ld. Special Judges (CBI/ACB), RACC, New Delhi

In the rare eventuality that none of the six Special Exclusive Courts designated for trying NIA/UAPA cases is available, the matter shall be taken up only by the Ld. Special Judges (CBI/ACB), who is on duty on that day.

The above shall be followed with immediate effect till further orders are issued.
