- (ii) The judicial officer(s) under transfer shall notify the cases in which they had reserved judgments/orders before relinquishing the charge of the court in terms of the posting/transfer order. The judicial officers shall pronounce judgments/orders in all such matters on the date fixed or maximum within a period of 2-3 weeks thereof, notwithstanding the posting/transfer. Date of pronouncement shall be notified in the cause list of the court to which the matter pertains as also of the court to which the judicial officer has been transferred and on the website.
- (iii) The court of Special Judge (PC Act) (CBI)-01, RACC earlier presided over by Mr. Gaurav Rao, stands abolished. The Ld. - (v) The court of ASJ(FTC)-03, South-East, Saket earlier presided over by Mr. Puneet Nagpal stands abolished. Ld. PDJ, South-East shall distribute the cases pending in this court equally amongst the courts of ASJ (FTC)-01 and ASJ(FTC)-02 in the district in equal proportion.
