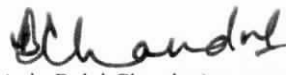
ORDER

Consequent upon recommendations given by the "Committee regarding Non-Functional Pay Scale Rs. 5400/-" in the meeting held on 21.08.2026 and in view of the deliberations already made by the said Committee in the earlier meetings held on 01.11.2019 & 12.12.2024 pursuant to the order dated 06.09.2010 passed by the Hon'ble Madras High Court in WP (C) No. 13225 of 2010, titled as "M. Subramaniam Vs. Union of India & Ors." & upheld by the Hon'ble Supreme Court of India vide order dated 10.10.2017 passed in Civil Appeal No. 8883 of 2011 and in terms of order dated 27.05.2016 passed by the Hon'ble High Court of Delhi in WP (C) No. 10508/2015 titled as "Sudhir Kumar & Ors. Vs.
