ORDER

As telephonically directed by Ld. Principal District & Sessions Judge-cum-Special Judge, (PC Act) (CBI), RADC, New Delhi, in partial modification of the Duty Judge Roster No. D.R. (SPL. Judges)/RACC/Gaz/2026/21366-21418/C dated 24.08.2026, it is hereby clarified that in the eventuality of any matter pertaining to MCOCA received beyond the regular Court hours, the same shall be put up before the senior most Ld. Special Exclusive Court dealing with MCOCA cases, who may assign the matter to himself/herself or assign the same to any other Special Exclusive Court designated for trying MCOCA cases, in terms of Sec. 5(5) of MCOCA Act. Such cases pertaining to MCOCA shall not be dealt with by the Ld. CJM or ACJMs or the Ld. Special Judges (CBI/ACB), RACC, New Delhi.

In the rare eventuality that none of the three Special Exclusive Courts designated for trying MCOCA cases is available, the matter shall be taken up only by the Ld. Special Judges (CBI/ACB), who is on duty on that day.

The above shall be followed with immediate effect till further orders are issued.
